Regional Qualifying Procedures

Qualification into the 2017 Region 2 Championships is determined by:

- 1) Must fall within the State's total allotment or,
- 2) Approved petitions – must meet requirements to petition

- **General Information Regarding Qualification**

State Allotment:

1. State allotment will be determined by the Region 2 Board based on regional participant numbers at the State Championships. State percentage is based on the number of a state's participants as a percentage of the regional numbers to achieve the target number of athletes qualified to the Region 2 Championships.
2. For 2017, at the compulsory levels, there **will not** be a differentiation between Division 1 & Division 2 for the allotment.
3. The "FINAL" allotment table is attached and also posted on the Region 2 web site at www.mensregion2.com.

Petitions:

1. If you are petitioning one of your athletes into Regionals, you will need to have all of the proper paperwork filled out at the conclusion of your state championships. The Official petition form can be found on line at:

2. You must include the following information if your petition is going to get consideration:
 - Petition form filled out in its entirety. (see link above for this form)
 - Official** meet results from at least two competitions showing your athlete's all-around score to be considered.
 - If it's an injury petition, a physician's statement as to the nature of the injury sustained.
 - Coach's statement supporting the petition.
 - Region 2 entry form filled out with petitioned athlete included on your roster.
 - Entry fee for \$135 included with the petition. (\$160 entry fee if you are petitioning a JE athlete)

Junior Elite Division:

1. Must compete on six events at the State Championships. No minimum qualifying score to qualify to the Region 2 Championships.

Specialists:

1. Region 2 has allowed specialist at the optional levels (Level 8 – 10 & JD) to qualify to the Region 2 Championships in the past. For 2017 the region will be taking 100% of all optional levels for the allotment. This means that there are no special qualification guidelines for specialists.
2. If an optional athlete competes less than 6 events at their respective state championships, they will only be allowed to compete on those events at Regionals.
3. Compulsory Level athletes will not be allowed to compete as a Specialist.
